As Usersdot Technology and Consulting Inc. (Company"), we use cookies to enhance your experience during your visits to online platforms. The use of these technologies is carried out in compliance with applicable legislation, primarily the Law on the Protection of Personal Data No. 6698 ("KVKK").

By using the www.usersdot.com website operated by us, cookies and similar technologies may be used within the scope of the Cookie Policy, stored on your device, and your personal data may be processed in accordance with the purposes and methods specified below and in the Privacy Notice.

What is Cookie?	Cookies are small electronic files or pieces of information that can be stored on your computer (or other internet-enabled devices such as smartphones and tablets) when you visit a website. Cookies are widely used in the virtual world and help to remember information about your device, such as language, settings, etc., due to the automatic pre-identification by web browsers during your visit.
What data is processed through cookies?	Cookies, depending on their types, collect data related to your browsing and usage preferences and habits on our website. This data includes all information about the pages you access, the services you browse, and your navigation on our site.
What are the purposes of using cookies?	Cookies are used for various purposes, including facilitating efficient navigation between web pages, enhancing the usability of websites, tracking your preferences to tailor content, graphics, and advertisements on the internet according to your needs, enriching and improving the overall user experience, statistically evaluating usage data for our websites to enhance their structures and contents, as well as customizing our services to better suit your interests and needs, and/or accelerating future activities and experiences on our websites.

What Are the Types of Cookies?

In terms of cookie management:

- **First-Party Cookies:** These are cookies created by us and placed on the website under our control.
- **Third-Party Cookies:** Cookies created and managed by third-party companies with whom we collaborate are referred to as third-party cookies.

In terms of storage duration:

- **Session Cookies:** These are cookies that are only present while your browser is open and are deleted when your browser is closed.
- **Persistent Cookies:** These are cookies that remain on your computer until a specified expiration date, even after your browser is closed. They can be used by websites to recognize your computer when you open your browser and browse the internet again.

In terms of usage purposes:

- **Necessary Cookies:** These cookies are necessary for the effective operation of websites, to provide various services through websites, and to perform some functions such as accessing secure areas. Without these cookies, it is not possible to provide some services such as shopping cart.
- **Performance Cookies:** These aim to provide an improved and personalized experience to users by allowing the saving of user preferences such as language settings on the website.
- **Analytical Cookies:** These are used to collect statistical information such as time spent on the website, pages visited, click information, and time spent on a page by web analytics tools to analyze website usage and to carry out more effective marketing activities.
- **Advertising Cookies:** These cookies collect information about your browsing habits and interests on the internet related to you and the topics you are interested in. They enable functions such as preventing the repetition of the same advertisements, displaying advertisements properly, and in some cases, displaying advertisements based on your interests.
